RULES AND REGULATIONS

Contest Procedure:** From all Diamond Club cards scanned at the admission gates on Opening Day, Friday November 9th, one random selection will be made by Del Mar Thoroughbred Club drawing officials. The Diamond Club member selected as the winner will be contacted by 2:00 pm. Winner does not need to be present to win.
