\$300,000 Guaranteed
(Grade II)**

A HANDICAP FOR THREE-YEAR-OLDS AND UPWARD By subscription of \$300 each, which shall accompany the nomination, or by supplementary nomination of \$3,000 each by Sunday, August 25 at noon, \$4,500 additional to start, with \$300,000 Guaranteed, of which \$180,000 to first, \$60,000 to second, \$36,000 to third, \$18,000 to fourth and \$6,000 to fifth. Weights Sunday, August 25. High weights preferred. In the event in which the race overfills, horses with equal weights (adjusted for age) will receive equal draw. **STARTERS TO BE NAMED THROUGH THE ENTRY BOX WEDNESDAY, AUGUST 28, BY THE CLOSING TIME OF ENTRIES.** The Del Mar Handicap has been selected as one of the Breeders' Cup "Win and You're In" Challenge Races. The nominated winner of the Del Mar Handicap will be entitled to automatic entry into the 2024 running of the Breeders' Cup Turf. The nominated winner will also be entitled to have pre-entry and entry fees waived for the Breeders' Cup Turf or will receive a credit equal to the Breeders' Cup Turf pre-entry and entry fee amount towards any other 2024 Breeders' Cup Championship Race. All horses will be entitled to receive a travel stipend if traveling from a base located outside the state of California. To be eligible for the 2024 Breeders' Cup World Championships to be held at Del Mar on November 1 and 2, all horses must be pre-entered by noon (local standard time at the designated place of pre-entry) on Monday, October 21, 2024. Winner must be Breeders' Cup nominated by pre-entry deadline to receive Challenge rewards. All Breeders' Cup Challenge Races and Breeders' Cup World Championship races are to be run Lasix free and in accordance with Breeders' Cup Limited rules as they may be published and/or amended from time to time, which rules are hereby expressly incorporated by this reference. All runners nominated to Challenge races and all Challenge winners are subject to out-of-competition testing by the Horseracing Integrity and Welfare Unit on behalf of the Horseracing Integrity and Safety Authority (or their respective designees). Breeders' Cup Limited reserves the right in its sole discretion to postpone, discontinue, amend, or change the conditions of all or any part of the Breeders' Cup Challenge "Win & You're In" race program. A trophy will be presented to the winning owner.
