FOR GOLDEN STATE SERIES ELIGIBLE CALIFORNIA BRED OR CALIFORNIA SIREB FILLIES, TWO YEARS OLD By subscription of \$100 each, which shall accompany the nomination, or by supplementary nomination of \$1,000 each (Non-Golden State Series eligible horses, \$25,000 to supplement -- which will make that horse eligible to all future Golden State Series stakes) by closing time of entries. All horses to pay \$1,500 additional to start, with \$100,000 Guaranteed, of which \$57,000 to first, \$19,000 to second, \$12,000 to third, \$6,000 to fourth, \$4,000 to fifth and \$2,000 to sixth. 124 lbs.; Non-winners of \$50,000 other than maiden or claiming allowed 3 lbs.; of a race other than claiming, 5 lbs. High weights preferred. Total non-claiming earnings will determine preference of horses with equal weights. STARTERS TO BE NAMED THROUGH THE ENTRY BOX FRIDAY, AUGUST 30 BY THE CLOSING TIME OF ENTRIES. A trophy will be presented to the winning owner. *\$50,000 to the winner.
