(Grade II)

FOR FILLIES AND MARES, THREE-YEAR-OLDS AND UPWARD By subscription of \$250 each, which shall accompany the nomination, or by supplementary nomination of \$2,500 each by closing time of entries, \$3,750 additional to start, with \$250,000 Guaranteed, of which \$150,000 to first, \$50,000 to second, \$30,000 to third, \$15,000 to fourth and \$5,000 to fifth. Three-year-olds 120 lbs.; Older 124 lbs.; Non-winners of a Grade I at one mile or over since November 1, 2024 allowed, 2 lbs.; of a Grade II at one mile or over in 2025 or a Grade I at one mile or over in 2024, 4 lbs. High weights preferred. Total earnings in non-claiming races in 2025 will be used in determining the preference of horses with equal weights. STARTERS TO BE NAMED THROUGH THE ENTRY BOX WEDNESDAY, SEPTEMBER 3 BY THE CLOSING TIME OF ENTRIES. A trophy will be presented to the winning owner.
