FOR TWO-YEAR-OLDS By subscription of \$100 each, which shall accompany the nomination, or by supplementary nomination of \$1,000 each by closing time of entries, \$1,500 additional to start, with \$100,000 Guaranteed, of which \$60,000 to first, \$20,000 to second, \$12,000 to third, \$6,000 to fourth and \$2,000 to fifth. Weight 123 lbs, Fillies, 120 lbs. Non-winners of \$50,000 allowed, 3 lbs.; \$30,000 other than claiming 5 lbs. High weights preferred. Preference of horses with equal weights will be determined by earnings. (Earnings in claiming & starter races of \$50,000 or less not considered).
