FOR THREE-YEAR-OLDS AND UPWARD WHICH ARE NON-WINNERS OF A SWEEPSTAKES OF \$50,000\* OTHER THAN STATE BRED AT ONE MILE OR OVER SINCE OCTOBER 1 FREE nominations close Thursday, July 11 or by supplementary nomination of \$1,000 each by closing time of entries. \$100 to pass the entry box and an additional \$1,500 to start, with \$100,000 Guaranteed, of which \$60,000 to first, \$20,000 to second, \$12,000 to third, \$6,000 to fourth and \$2,000 to fifth. Three-year-olds 120 lbs.; Older 125 lbs. Non-winners of \$35,000 twice other than maiden or claiming at one mile or over since March 1 or such a race of \$60,000 since May 1, 2023 2 lbs.; of such a race of \$40,000 in 2024 or such a race of \$50,000 in 2023 4 lbs. High weights preferred. Second preference. Gr. stakes winners in 2023. Preference of horses with equal weights will be determined by 2024 non-claiming earnings.
