Three-year-olds 121 lbs.; Older 125 lbs. Non-winners of \$35,000 twice since April 1 or \$60,000 at one mile or over since June 1, 2023, allowed 2 lbs.; of \$50,000 at one mile or over in 2024, 4 lbs.; of \$50,000 since September 1, 2023, 6 lbs. (Maiden and claiming races not considered). High weights preferred. Total non-claiming earnings in 2024 will be used in determining the preference of horses with equal weights. STARTERS TO BE NAMED THROUGH THE ENTRY BOX FRIDAY, AUGUST 30 BY THE CLOSING TIME OF ENTRIES. *\$50,000 to the winner.
