FOR THREE-YEAR-OLDS AND UPWARD. By subscription of \$200 each, which shall accompany the nomination, or by supplementary nomination of \$2,000 each by the closing time of entries, \$3,000 additional to start, with \$200,000 Guaranteed, of which \$120,000 to the winner, \$40,000 to second, \$24,000 to third, \$12,000 to fourth and \$4,000 to fifth. The Pat O'Brien Stakes has been selected as one of the Breeders' Cup "Win and You're In" Challenge Races. The nominated winner of the Pat O'Brien Stakes will be entitled to automatic entry into the 2017 Breeders' Cup Dirt Mile. The nominated winner of the Pat O'Brien Stakes will also be entitled to have pre-entry and entry fees waived for the Breeders' Cup Dirt Mile or will receive a credit equal to the Breeders' Cup Dirt Mile pre-entry and entry fee amount towards any other Breeders' Cup Championship Race, and will be entitled to receive a travel stipend if traveling from a location outside California. To be eligible for the 2017 Breeders' Cup Championships to be held at Del Mar on November 3 and 4, 2017, all horses must be pre-entered by noon (local time at the designated pre-entry locations) by Monday, October 23, 2017. Winner must be Breeders' Cup nominated by pre-entry deadline to receive Challenge rewards. Any horse which wins a Challenge Race may be subject to California Horse Racing Board out-of-competition testing up to Breeders' Cup Championship Day. Three-year-olds 120 lbs.; Older 123 lbs. Non-winners of a Grade I since November 1, 2016 allowed 2 lbs.; of a Grade II in 2017 or a Grade I in 2016, 4 lbs. **STARTERS TO BE NAMED THROUGH THE ENTRY BOX WEDNESDAY, AUGUST 23, BY THE CLOSING TIME OF ENTRIES.** A trophy will be presented to the winning owner.
