## Jimmy Durante Stakes \$100,000 Guaranteed (Grade III)

**FOR FILLIES, TWO YEARS OLD** By subscription of \$100 each to accompany the nomination or by supplementary nomination of \$1,000 each by the closing time of entries, \$1,500 additional to start, with \$100,000 Guaranteed, of which \$60,000 to first, \$20,000 to second, \$12,000 to third, \$6,000 to fourth and \$2,000 to fifth. 124 lbs. Non-winners of a stakes of \$60,000\* at one mile or over allowed 2 lbs.; such a race at any distance, 4 lbs. High weights preferred. Second preference will be given to those horses that placed (second or third) in a Gr. stakes. Preference of horses with equal weights will be determined by earnings.
