## Golden State Juvenile Fillies Stakes

**\$150,000 Guaranteed**

**FOR GOLDEN STATE SERIES ELIGIBLE CALIFORNIA BRED OR CALIFORNIA SIRE FILLIES TWO YEARS OLD** By subscription of \$150 each to accompany the nomination or by supplementary nomination of \$1,000 each by the closing time of entries for Golden State eligible horses. (non-Golden State eligible horses, \$25,000 to supplement -- which will make that horse eligible to all future Golden State Series Stakes) \$2,250 additional to start, with \$150,000 Guaranteed, of which \$85,500 to first, \$28,500 to second, \$18,000 to third, \$9,000 to fourth, \$6,000 to fifth and \$3,000 to sixth. Weight: 124 lbs. Non-winners of a sweepstakes allowed 2 lbs.; of two races other than claiming or starter, 4 lbs. High weights preferred. Starters to be named through the entry box by the closing time of entries. Total non-claiming earnings will be used in determining the preference of horses assigned equal weights. **STARTERS TO BE NAMED THROUGH THE ENTRY BOX SATURDAY, OCTOBER 31, BY THE CLOSING TIME OF ENTRIES.** A trophy will be presented to the winning owner.
