**A HANDICAP FOR THREE-YEAR-OLDS AND UPWARD** By subscription of \$250 each, which shall accompany the nomination, or by supplementary nomination of \$2,500 each by Sunday, August 13 at noon, \$3,750 additional to start, with \$250,000 Guaranteed, of which \$150,000 to first, \$50,000 to second, \$30,000 to third, \$15,000 to fourth and \$5,000 to fifth. The Del Mar Handicap has been selected as one of the Breeders' Cup "Win and You're In" Challenge Races. The nominated winner of the Del Mar Handicap will be entitled to automatic entry into the 2017 running of the Breeders' Cup Turf. The nominated winner will also be entitled to have pre-entry and entry fees waived for the Breeders' Cup Turf or will receive a credit equal to the Breeders' Cup Turf pre-entry and entry fee amount towards any other Breeders' Cup Championship Race, and will be entitled to receive a travel stipend if traveling from a location outside California. To be eligible for the 2017 Breeders' Cup Championships to be held at Del Mar on November 3 and 4, 2017, all horses must be pre-entered by noon (local standard time at the designated pre-entry locations) by Monday, October 23, 2017. Winner must be Breeders' Cup nominated by pre-entry deadline to receive Challenge rewards. Any horse which wins a Challenge Race may be subject to California Horse Racing Board out-of-competition testing up to Breeders' Cup Championship Day. Weights Sunday, August 13. High weights preferred. **STARTERS TO BE NAMED THROUGH THE ENTRY BOX WEDNESDAY, AUGUST 16, BY THE CLOSING TIME OF ENTRIES.** A trophy will be presented to the winning owner.
