**FOR GOLDEN STATE ELIGIBLE CALIFORNIA BRED OR CALIFORNIA SIREB FILLIES AND MARES THREE YEAR OLDS AND UPWARD** By subscription of \$100 each to accompany the nomination or by supplementary nomination of \$1,000 each by closing time of entries for Golden State eligible horses. (Non-Golden State eligible horses, \$25,000 to supplement -- which will make that horse eligible to all future Golden State Series Stakes) \$1,500 additional to start, with \$100,000 Guaranteed, of which \$57,000 to first, \$19,000 to second, \$12,000 to third, \$6,000 to fourth, \$4,000 to fifth and \$2,000 to sixth. Three-year olds 122 lbs. Older 124 lbs. Non-winners of a sweepstakes of \$60,000 since May 30 allowed 2 lbs.; of \$35,000 since April 1 allowed 4 lbs.
