Three-year-olds 118 lbs.; Older 124 lbs. Non-winners of a Grade I at one mile or over since November 1, 2016 allowed 2 lbs.; of a Grade II at one mile or over in 2017 or a Grade I at one mile or over in 2016, 4 lbs. High weights preferred.
