32nd Running Of Real Good Deal Stakes \$150,000 Guaranteed

FOR GOLDEN STATE SERIES ELIGIBLE CALIFORNIA BRED OR CALIFORNIA SIRE THREE-YEAR-OLDS By subscription of \$150 each, which shall accompany the nomination, or by supplementary nomination of \$1,500 each (non-Golden State Series eligible horses, \$25,000 to supplement -- which will make that horse eligible to all future Golden State Series Stakes) by closing time of entries. All horses to pay \$2,250 additional to start, with \$150,000 Guaranteed, of which \$85,500 to first, \$28,500 to second, \$18,000 to third, \$9,000 to fourth, \$6,000 to fifth, \$3,000 to sixth. Weight 123 lbs.; Non-winners of \$30,000 twice allowed 3 lbs.; of \$20,000 since March 1, 5 lbs. (Maiden and claiming races not considered.) Grade I winners to carry 127 lbs. Grade II winners to carry 125 lbs.(regardless of allowances) A trophy will be presented to the winning owner.
