FOR THREE YEAR OLDS AND UPWARD By subscription of \$200 each to accompany the nomination, or by supplementary nomination of \$2,000 each by the closing time of entries. \$3,000 additional to start, with \$200,000 Guaranteed, of which \$120,000 to first, \$40,000 to second, \$24,000 to third, \$12,000 to fourth and \$4,000 to fifth. Three-year-olds 122 lbs. Older 126 lbs. Non-winners of a Gr I at one mile or over in 2019-20 allowed 2 lbs., a Gr II at a mile or over in 2019-20, 4 lbs. This race will not be divided. High weights preferred. Second preference will be given to horses placed (second or third) in a Gr I or Gr II or Gr III winners in 2020. Total non-claiming earnings in 2020 will be used in determining the order of preference of horses with equal status. STARTERS TO BE NAMED THROUGH THE ENTRY BOX SATURDAY, NOVEMBER 21, BY THE CLOSING TIME OF ENTRIES. A trophy will be presented to the winning owner.
