\$300,000 Guaranteed
(Grade I)**

FOR THREE-YEAR-OLDS AND UPWARD By subscription of \$300 each, which shall accompany the nomination or by supplementary nomination of \$3,000 each by closing time of entries, and \$4,500 additional to start, with \$300,000 Guaranteed, of which \$180,000 to first, \$60,000 to second, \$36,000 to third, \$18,000 to fourth and \$6,000 to fifth. The Bing Crosby Stakes has been selected as one of the Breeders' Cup "Win and You're In" Challenge Races. The nominated winner of the Bing Crosby Stakes will be entitled to automatic entry into the 2019 Breeders' Cup Sprint. The nominated winner will also be entitled to have pre-entry and entry fees waived for the Breeders' Cup Sprint or will receive a credit equal to the Breeders' Cup Sprint pre-entry and entry fee amount towards any other Breeders' Cup Championship Race, and will be entitled to receive a travel stipend if traveling from a location outside California. To be eligible for the 2019 Breeders' Cup Championships to be held at Santa Anita on November 1 and 2, 2019, all horses must be pre-entered by noon (local standard time at the designated pre-entry locations) by Monday, October 21, 2019. Winner must be Breeders' Cup nominated by pre-entry deadline to receive Challenge rewards. Any horse which wins a Challenge Race may be subject to out-of-competition testing up to Breeders' Cup Championship Day. Three-year-olds 119 lbs.; Older 123 lbs. Non-winners of a Grade I since November 1, 2018 allowed 2 lbs.; of a Grade II in 2019 or a Grade I in 2018, 4 lbs. trophy will be presented to the winning owner.
