FOR THREE YEAR OLDS AND UPWARD By subscription of \$250 each to accompany the nomination, or by supplementary nomination of \$2,500 each by the closing time of entries. \$3,750 additional to start, with \$250,000 Guaranteed, of which \$150,000 to first, \$50,000 to second, \$30,000 to third, \$15,000 to fourth and \$5,000 to fifth. Three-year-olds 122 lbs. Older 126 lbs. Non-winners of a Gr I at one mile or over in 2021-22 allowed 2 lbs., a Gr II at a mile or over in 2021-22, 4 lbs. This race will not be divided. High weights preferred. Second preference will be given to horses placed (second or third) in a Gr I or Gr II in 2022 or Gr III winners in 2022. Total non-claiming earnings in 2022 will be used in determining the order of preference of horses with equal status. STARTERS TO BE NAMED THROUGH THE ENTRY BOX SUNDAY, NOVEMBER 20, BY THE CLOSING TIME OF ENTRIES. A trophy will be presented to the winning owner.
