## Hollywood Turf Cup \$250,000 Guaranteed (Grade II)

**FOR THREE YEAR OLDS AND UPWARD** By subscription of \$250 each to accompany the nomination, or by supplementary nomination of \$2,500 each by the closing time of entries. \$3,750 additional to start, with \$250,000 Guaranteed, of which \$150,000 to first, \$50,000 to second, \$30,000 to third, \$15,000 to fourth and \$5,000 to fifth. Three-year-olds 122 lbs. Older 126 lbs. Non-winners of a Gr I at one mile or over in 2020-21 allowed 2 lbs., a Gr II at a mile or over in 2020-21, 4 lbs. This race will not be divided. High weights preferred. Second preference will be given to horses placed (second or third) in a Gr I or Gr II in 2021 or Gr III winners in 2021. Total non-claiming earnings in 2021 will be used in determining the order of preference of horses with equal status.
